# **Reading of Notice**

Commissioner Simon read the public hearing notice to consider the request for a conditional use permit amendment to modify the approved site plan to allow for a building addition for a contractor's yard, for the property located at 9601 Jefferson Trail. 13 notices were mailed.

#### **Presentation of Request**

Heather Botten, Associate Planner, explained the request as detailed in the report. She advised that the property is zoned I-1, Limited Industrial and consists of two parcels. The applicant is requesting a CUP amendment to add a 47' x 52' addition on the north side of the existing building. The request meets the general CUP criteria and the use is consistent with the comprehensive plan. Staff recommends approval of the request with the six conditions listed in the report. Staff did not hear from any neighboring property owners.

### **Opening of Public Hearing**

Nick Marsden, 10267 – 102<sup>nd</sup> Court West, advised he was available to answer any questions.

Chair Maggi asked the applicant if he read and understood the staff report.

Mr. Marsden replied in the affirmative. He advised that they are a growing company and are proposing to build the addition to store their materials and equipment. He stated they keep their property tidy and have not received complaints from neighbors.

Chair Maggi closed the public hearing.
